Labelling on its own is of limited effectiveness in educating about the associated hazards such as infrequent washing of bedding / clothing and cigarette smoking, so an education and awareness campaign should be conducted, targeting dermatologists, healthcare professionals, aged care and residential facilities and in-home carers.

Many emollient products used in large quantities are cosmetics (e.g. large tubs of emulsifying ointment) and in some cases devices (e.g. bandages impregnated with petroleum jelly). Medsafe should work with other NZ regulatory agencies that have oversight of devices and cosmetics (ERMA) to ensure that other products that are used for similar purposes also carry this important safety information.
