The Society welcomes the proposal to amend the Medicines Regulations to clarify that Fluoride used for fluoridating water supplies is not a medicine.

Question 2

Are there other fluoride-containing compounds used to treat community water supplies that should be specifically named in the regulation? If so, what are they?

The proposal specifies Hydrofluorosilicic acid and Sodium silico fluoride: these are the compounds most suited to community water fluoridation.

Sodium Fluoride can also be used and is more suited to smaller water systems. It would seem sensible to include Sodium Fluoride in the amendment to the Regulations so that they are complete and clear.

Dear Sir/Madam,

As fluoride agents added to drinking water supplies are added for the sole purpose of providing a therapeutic effect, ie prevention of tooth decay, I submit that these agents must be classified as medicines and assessed as such.

The current substances used for water fluoridation are not pharmaceutical grade and therefore contain amounts of heavy metals and toxic chemicals that would not be permitted under the Act and I believe it is one reason why an exemption is being sought.

To start exempting products claiming a therapeutic purpose from classification and oversight under the Act would pave the way for future discretionary decisions on the use of other products that are not pharmaceutical grade quality.

The Dangerous Substances Regulations 2001, prescribe water quality standards in relation to certain substances in surface waters, e.g., rivers, lakes and tidal waters. The substances include certain pesticides (atrazine, simazine, tributyltin), solvents (dichloromethane, toluene, xylene), metals (arsenic, chromium, copper, lead, nickel, zinc) and certain other compounds (cyanide and fluoride). Public water fluoridation is a common policy for improving dental health. Fluoride replaces the hydroxyls of hydroxyapatite, thereby improving the strength of tooth enamel, but this process can also occur in other active calcifications. This paper studies the effects of water fluoridation during the course of vascular calcification in renal disease. The effect of fluoride was studied in vitro and in vivo. Rat aortic smooth muscle cells were calcified with 2mM Pi for 5 days. Fluoride concentrations of 5-10 µM--similar to those found in people who drink fluoridated water--partially prevented calcification, death, and osteogene expression in vitro. The anticalcifying mechanism was independent of cell activity, matrix Gla protein, and fetuin A expressions, and it exhibited an IC50 of 8.7 µM fluoride. In vivo, however, fluoridation of drinking water at 1.5mg/L (concentration recommended by the WHO) and 15 mg/L dramatically increased the incipient aortic calcification observed in rats with experimental chronic kidney disease (CKD, 5/6-nephrectomy), fed a Pi-rich fodder (1.2% Pi). Fluoride further declined the remaining renal function of the CKD animals, an effect that most likely overwhelmed the positive effect of fluoride on calcification in vitro. Ultrastructural analysis revealed that fluoride did not modify the Ca/P atomic ratio, but it was incorporated into the lattice of in vivo deposits. Fluoride also converted the crystallization pattern from plate to rode-like structures. In conclusion, while fluoride prevents calcification in vitro, the WHO's recommended concentrations in drinking water become nephrotoxic to CKD rats, thereby aggravating renal disease and making media vascular calcification significant.

There's a substantial body of mutagenesis studies, that is studies where a chemical's ability to cause changes in DNA have been proven. Also, fluoride is known to be an enzyme poison in any number of enzyme systems. And repair of damaged DNA by enzymes is an important anti-cancer mechanism that the body has.

If some of these repair enzymes are inhibited by fluoride, it could indicate fluoride's ability to work as what we call a 'promoter' as opposed to a 'primary' carcinogen.

Carcinogenesis is a very interesting and complex subject. There are so called 'complete carcinogens' - chemicals that in fact damage the DNA and then allow an aberrant cell to reproduce wildly and develop a malignant tumor. There are other substances which are called 'promoters' which do things like inhibit repair enzymes and once an incipient cancer forms - if these repair enzymes are not able to go in, sense the aberrant cell or the aberrant strands of DNA, and either repair the DNA or kill the cell - then the tumor is allowed to grow. Those are classified as promoters.

It may well be that fluoride works in both ways as a primary carcinogen and as a promoter.

Q: And it would be a promoter of cancer by damaging or inhibiting the enzymes that can be protective?

Hirzy: That's right.

Q: If these tumors in the rats weren't downgraded by the National Toxicology Program, what would have been the ramifications for fluoridation?

Hirzy: It would have been over. If in fact the classification of Probable Human Carcinogen, which would have flowed from the finding of clear evidence here, it would have required that the EPA set a Maximum Contaminant Level Goal of zero. All carcinogens have a Maximum Contaminant Level Goal of zero. That is, you recall, the health based standard, the one EPA sets saying that at this level we anticipate no adverse health effects in the entire population with an adequate margin of safety. Fluoride and Cancer

New York -- February 6, 2002 -- Fluoride added to public water supplies may be linked to cancer suggests two new studies. "The likelihood of fluoride acting as a genetic cause of cancer requires consideration", writes Takahashi and colleagues in the July 2001 "Journal of Epidemiology (1) who found that 23 of 36 cancer sites (63.9%) were associated positively with fluoridation status, using World Health Organization data and the U.S. Fluoridation Census.

Some studies, e.g., Hoover (1976) and Knox (1985) claim no credible fluoridation/cancer association exists. However, Takahashi and co-authors found the Hoover/Knox assessments flawed, and explain why in their paper. The authors report that the National Cancer Institute provided epidemiological evidence of a relation between cancer incidence and water fluoridation in 1987. These findings provoked a 1990 National Toxicology Program (NTP) study that determined fluoride could be a cancer-causing agent.

The NTP study "supplied a detailed description of the toxicology of fluoride, not only in terms of osteosarcoma, but also lesions in the oral mucosa, thyroid gland, skin and uterus...(which) prompted us to re-test the hypothesis of an epidemiological association between water fluoridation and cancer incidences...", wrote Takahashi who found fluoridation status positively correlates to cancers of the oral cavity, pharynx, colon, rectum, hepato-bilary & urinary organs and bone cancer in males.

Such a broad spectrum association has never been observed for any particular known carcinogen, but it may be reasonable for fluoride, because of its strong electronegative nature, the authors explain.

After ten years of water fluoridation, children aged 7-18 in Newburgh, N.Y., had more cortical bone defects than the non-fluoridated control city, Kingston. And more osteosarcoma occurred in young males in fluoridated portions of New Jersey. ... these two facts may be connected pathophysiologically, Takahashi reports. Takahashi urges researchers worldwide to further assess fluoride as a genetic cause of cancers...and stop the application of fluoride for prevention of teeth caries (cavities) if this indeed presents as a risk factor for cancer.

In another study, (2) Ramesh and colleagues propose that high fluoride bone content might have been one of the major factors causing osteosarcoma, in the Journal of Environmental Pathology, Toxicology and Oncology, 2001, Vol. 20, Issue 3.

Ramesh, et al, analyzed bone samples of 20 Indian osteosarcoma patients. The very high levels of fluoride accumulation in the bone samples of (2 Indian osteosarcoma patients) in which p53 gene mutation have also been detected suggest that possible adverse effects of fluoride on the DNA of the osteosarcoma patients, Ramesh and colleagues write.

Mutations in the p53 genes are the most commonly observed genetic alterations in human cancer. Ramesh concludes that fluoride probably causes mutations in p53.

"These new findings raise important questions about potential harm from water fluoridation, especially when coupled with the current recognition that ingesting fluoride does not reduce tooth decay but has caused a massive increase in disfiguring dental fluorosis," says lawyer Paul Beeber, President, New York State Coalition Opposed to Fluoridation.

	Our members voted unanimously at our AGM in May 2014 to support community water fluoridation

projects in Aotearoa.

- Also, the three articles of the Treaty of Waitangi 1840 contributes to health, in its principles of Partnership (working with iwi, hapu and whanau to develop strategies for Maori health gain; Participation (involving Maori at all levels of decision making, planning, development and delivery of health services; and Protection (working to ensure Maori have at least the same level of health as non-Maori, and safeguard Maori cultural concepts, views and practices).
- Furthermore, Professor John Broughton (Ngai Tahu, Ngāti Kahungunu and Patron of Te Ao Mārama NZ Māori Dental Association) wrote in 2008. "In te ao hou (the contemporary world), the fluoridation of water supplies does not conflict with the concept of waiora (the water of life) because fluoridated water brings good oral health and wellbeing by protecting the dentition and the life of the teeth."
- Finally, Justice Collins has made it very clear in his ruling of 9 October 2014 [1] that fluoride added to the drinking water supply is not a medicine, within the meaning of the Medicines Act, because the maximum allowable concentration in drinking water is 1mg/L and Schedule 1 of the Medicines Regulations specifies that every reference to a medicine in the Schedule only applies if the concentration of that medicine is greater than 10 mg/L.

Sodium fluoride and SFS are supplied as powders that are dissolved in water to make a solution that is then added to the water supply while FSA is supplied as a liquid. Fluoride is added to the water at a controlled rate relative to the flow through the treatment plant to achieve a target concentration in the treated water. 

Fluoride is the only medication I know of that is given in indiscriminate doses (through town water supplies) to an entire population WITHOUT the consent of that population. That in of itself is totally WRONG!

If people do need fluoride (and I don't believe they do personally) then it should be proscribed by a dentist and administered to an individual patient at the correct dose for that person, with that person or the guardian of that person's FULL and INFORMED consent. All risks and side effects of fluoride should be explained to that person, just as it should be with any other medicine.

Fluoridating water breaches all of these standards usually applied to every other medication I certainly know of. I fear that, by exempting fluoride from the Medicines Act 1981, that it will undermine the Act itself. I fear that if fluoride is exempt, what other potentially harmful substances can be exempt from the Act at the whim of the government of the day? I feel that the Medicines Act was enacted for a reason... and a very noble one. Exempting substances at the whim of the government of the day is, in my opinion, a very dangerous and slippery slope to go down. I personally do not want to see New Zealand go down this road of eroding acts like the Medicines Act 1981 that were enacted for a very good public health reason.

What I want to know is what makes fluoride so important and so "special"? What sets fluoride aside from every other medicine that it needs to be exempt from the Medicines Act?

Fluoride should not be a medication that is forced on those of us who do not need it and/or who do not WANT it. I choose not to put fluoride into my body. I should, as an adult, have that right to choose what does and does not go into my body. I should also have that right to make those choices over my dependents' bodies as well. I do not need a nanny state to make those choices for me. Thank you.






