NOTIFICATION OF TEMPORARY ALTERNATIVE PRODUCT SUPPLY

Pfizer New Zealand Limited (Pfizer) wishes to advise that, due to a delay at the manufacturing site, there will be intermittent supply of NORIMIN® 28 Day (3 blisters x 28 tablets) between now and late January 2026.

The blister foils are also identical (silver area containing active tablets and red area containing placebo tablets). The only differences are in the artwork and patient information documents.
